## BESTSELLER Gift Cards - General Terms and Conditions for Cardholders in Malta

The following Terms of Use (the 'Terms') apply for the BESTSELLER gift card ('BESTSELLER Card').

- 1. The BESTSELLER Card is issued by fashioncheque holding B.V. bearing company registration number 34252189, VAT number NL816058982B01 and its registered address at Kruisweg 801-C, 2132 NG Hoofddorp, The Netherlands (the 'Issuer').
- 2. The sale of a BESTSELLER Card involves the retailer, from whom the BESTSELLER Card is purchased, acting on behalf of the Issuer.
- 3. A BESTSELLER Card remains valid for four years following its purchase, after which the credit expires.
- 4. Any unused or residual credit on the BESTSELLER Card cannot be refunded or exchanged for cash.
- 5. BESTSELLER Cards cannot be recharged with additional credit.
- 6. The maximum credit on a BESTSELLER Card is EUR 500.
- 7. BESTSELLER Cards are not personal and are therefore transferable.
- 8. When purchasing a BESTSELLER Card online as a digital voucher, the BESTSELLER Card is provided as a digital product, with immediate access. By accepting these Terms, the Cardholder acknowledges that upon receiving the BESTSELLER Card, the contract becomes fully performed, and the right of withdrawal is waived.
- 9. Once the BESTSELLER Card is issued, it cannot be replaced or exchanged. If the card is altered, rendered ineligible or defaced, it will be considered invalid.
- 10. The BESTSELLER Cards cannot be blocked.
- 11. BESTSELLER Cards are may be used at all participating retailers in Malta<sup>1</sup>
- 12. BESTSELLER Cards may only be used to purchase the following products: clothing, including shoes and accessories (such as bags and jewellery), cosmetics and fragrances.
- 13. The amount on the BESTSELLER Card can be used to pay part or all of the purchase price.
- 14. The Issuer assumes no responsibility or liability for any loss, theft, expense, damage or unauthorised use of the BESTSELLER Card, unless caused by the Issuer.
- 15. The Issuer assumes no responsibility or liability for claims, demands, losses, costs, expenses arising from any dealings between the customer and the retailer.
- 16. These Terms are governed by the laws of Malta. The Courts of Malta shall have exclusive jurisdiction over all claims and disputes arising in relation to or in connection with these Terms.
- 17. BESTSELLER Cards purchased and activated in Malta can also be redeemed in Albania, Andorra, Austria, Belgium, Bosnia and Herzegovina, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Faroe Islands, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Monaco, Netherlands, Norway, Poland, Portugal, Serbia, Slovakia, Slovenia, Spain, Sweden, Switzerland, Turkey, United Kingdom.
- 18. The Issuer reserves the right to vary these Terms from time to time.
- 19. These Terms have been last updated in March 2025.
